  Public comment:
  - a. None
- 3. Consent agenda: Minutes approved with no comments.
- 4. Reports and Updates:
  - a. Insurance Committee: Juanita provided an update from the Insurance Committee. The Committee met and reviewed different insurance options after speaking with an independent broker. The Committee is recommending that Adelante stay with the SBUSD plan for this year. The Committee is also recommending that Adelante offer classified employees who qualify for insurance a rate that is \$133 less than the amounts noted. These employees are the most impacted by the rates. This only applies to 2 employees and will be a cost of \$1,460 over 11 months to Adelante and is well within what is allocated in the budget. The Committee also recommends that Adelante look at insurance options for 2015-16 in March 2015. The Board reviewed and discussed.
