- 1. Call to Order, attendance / (5:39 pm)
 - a. Non-board members present: Javier Bolivar, Holly Gil, Sandra Limon, William Banning (SBUSD Board Member liason)

- 7. Reports & Updates
 - a. Celebration of Teaching: Maestra Lemus reviewed the learning highlights in each grade and specialist area.
 - b. PTSO (Keila Gonzalez)
 - i. Día de los Muertos Adelante Event-Nov. 5, 2023
 - Stage-ready, performance-ready, and working on layout. The event will be held at the Adelante Campus
 - 2. T-shirt contest: winners will be announced tomorrow (October 3, 2023)

 - Academic Committee: Plans for Strategic Planning Retreat at the beginning of the year.
 - ii. The finance committee will meet next month.
- d. Finance Report (Roger Castillo)
 - August 2023 Updates: Showed higher than forecasted revenues as well as expenses.
 - ii. For the academic year 2023-2024 most likely we will be in a small deficit.
 - iii. Cash Balance: 3.3 million above the 15% reserve goal.
- e. ED-Principal's Report
 - i. Reviewed ELPAC and ELD trainings; new math curriculum
 - ii. Parent night on Oct. 11, 2023, to show parents how to read ELPAC scores.(Mirian Gutierrez offered to support)
 - iii. Brianna Aguilar: suggests recognizing the families and students who get reclassified in a celebration this academic year.
- f. Special Education Director Update
 - i. 160 students' vision was screened by the Lions Club; students who were flagged with vision problems have been sent referrals for eye exams.
 - ii. Speech/Occupational Therapy update:
 - If families would like extra support there are other resources in town. One is the Alpha Resource Center.

 - a. Discuss Universal Pre-K: No Update.
- 9. Action Items (6:45)
 - Approve an increase in the portion of health insurance paid by Adelante for employees
 - i. Insurance costs have increased; SBUSD is subsidizing more. Last academic year the board approved a monthly \$50 increase to staff insurance and Adelante was above what SBUSD was subsidizing but now that the district increased, we



- are below. Therefore, an increase is being requested so Adelante matches what SBUSD is offering.
- ii. Norma Quezada estimated the impact on the budget would be \$9,000.
- iii. Brianna Aguilar made a motion to approve the increase in Adelante's portion to match SBUSD and retroactively. Jack Rivas seconded; motion passed 5-0.
- 10. Next meeting dates: November 14, December 4, as well as second December meeting.
