    - Blanca Figueroa presented about the last EBAC meeting, which was held on March 21, 2024. 16 families attended. The main discussion included an overview of the Adelante Curriculum, and parents had an opportunity to visit various



classrooms to better understand what each grade is learning. Parents were also able to give input on the questions that will be on the EBAC needs assessment survey.

- d. Committee Reports (food, finance, academic, family relations, equity)
  - i. The fundraising committee met with teachers and is working with teachers, staff, and parents to raise funds for Adelante.
  - ii. The committee completed the mission statement
  - iii. The committee has leads on some donors for Adelante
- e. Finance Report (Roger Castillo)
  - i. Roger Castillo reviewed the February 2024 financial report:
  - ii. Adelante's financial position remains stable for the next academic year.
  - iii. Adelante started receiving \$10K in cash for the Arts Music in Schools Grant.
    - 1. The grant total is \$50,000-5 payments throughout the next academic year and must be spent in the 24-25 academic year.
    - 2. Due to funding regulations, the money can not supplement what is already happening at the school. Adelante must find new art initiatives to fund.

- g. Update on development of 2024-2027 LCAP
  - i. Adelante is in the phase of Engaging Educational Partners. Surveys are being administered to gather data to inform LCAP better. Surveys being conducted are:
    - 1. Adelante School Survey
    - 2. Healthy Kids Survey by West Ed
    - 3. EBAC Needs Assessment Survey
    - 4. Small focus group with special education program

- a. There were seven teacher observations this year. Teachers will get their feedback at the end of the year.
- b. The director is continuing instructional rounds
- c. Continuing planning meetings for next academic year with Holly.
  - Review data from the English and Spanish reading assessments with each teacher and use the feedback to inform what support will be needed for next year's students.
- d. Winter Outcomes:



- i. Reading Spanish-EDL (1st-6th) and English-DRA (3rd-6th) Tests (Administered 1:1 assesses accuracy, fluency, and comprehension)
  - 1. There is a decrease in students who are needing intervention
  - 2. We will continue monitoring the 4th-grade cohort, which were the most affected by distance learning. This group is showing improvement.
- ii. Star 360 Assessments Computer adaptive assessments
  - 1. Scores are encouraging
- iii. STAR Reading and Math Test
  - 1. Students are finding this test more difficult.
    - a. They take the test on a computer.
    - b. In the EDL and DRA tests, students read at a higher level, but in the STAR test, we do not see students applying their skills.
    - c. Performing well in Math (Spanish)
    - d. Not performing well in math (English)
      - A possible change next year is to start teaching math in English in earlier grades.
